National Digital and Data Consultations

The Government of Canada has announced national consultations on digital and data transformation policies. During summer 2018, a series of roundtables will be held across Canada with businesses, academia, civil society, and other stakeholders. All Canadians are able to contribute to the discussions via the National Digital and Data Consultations website.



On July 10th, the 11th edition of the Global Innovation Index 2018 (GII), co-published by Cornell University, INSEAD, and the World Intellectual Property Organization, was released. The United States slipped 2 spots and is now ranked 6th in the world; China rose 5 spots and is now ranked 17th. Canada remained steady in the 18th spot.

The GII uses 80 indicators to provide detailed metrics about the innovation performance of 126 countries in the world. The indicators focus on a broad range of innovation factors, including political environment, education, infrastructure and business sophistication.

However, a recent piece of artwork honouring the Humboldt Broncos, uploaded to Redbubble by a non-artist, raises moral and copyright issues with the commercial validity of these promising online marketplaces.
