The Competition Bureau has opened <u>public consultations</u> until Dec 31, 2018 on the latest version of the Intellectual Property Enforcement Guidelines.

A <u>study</u> published by the European Patent Office (EPO) finds the number of European patent applications related to automated driving has grown 20 times faster than other technologies in recent years.

CRTC <u>invites</u> comments on the creation of a mandatory <u>code of conduct for ISPs</u>. Submission deadline is December 19, 2018.

Broadcasting and Telecommunications Legislative Review Panel consultation: '<u>Responding to the</u> <u>New Environment: A Call for Comments</u>' written submission deadline is November 30, 2018.
